Matthew J. Borges, Roetzel's Government Relations Director, Awarded Proclamation by Cleveland City Council Members

On August 12, 2014, in a brief ceremony at Roetzel's Cleveland office, <u>Matthew J. "It's been a remarkable experience and Cleveland put on an extraordinary presentation. At the end of the day, the other cities just couldn't compete with the facilities that we can offer downtown and at the Q – the city was able to show that it would be ready to go from day one."

Sweeny credited "a great collaborative effort by the Republican Party, the City of Cleveland and its business leaders" for the success of the campaign to bring the convention to Cleveland.
