On March 12, 2020, Governor DeWine ordered all K-12 schools to close for three weeks beginning at the close of school on Monday, March 16, 2020. Within the next couple of days, the Ohio Department of Education ("ODE") will be sending further guidance to schools on how to handle the school closure issue.
