# Time to Think About Saving Tax Dollars in 2005

### There are many ways to make non-cash donations

Here are tips for making nontraditional charitable contributions:

**#1:** Appreciated Property. Generally, you may deduct the fair market value of long-term capital gain property as of the

contribution date (but see tips 2 & 3). Long-term capital gain property is held > 1 year. Deductions for ordinary income property (inventory, art,

and assets held 1 year or less) are generally just your basis (your cost) in the property, not fair market value.

**#2:** Public Charity. You can deduct the fair market value of

contributions to public charities (charities funded by the public). In most cases, your deduction is limited to your basis for contributions to private charities like family foundations.

**#3:** "Related Use Rule." The "related use rule" for public charity donations requires that the use of the property by the charity is related to its charitable purpose. Donations must be of a type normally retained or used by the charity. If the related use rule isn't satisfied, you may only deduct your basis.

**#4:** Don't Sell - Donate. Intangible property includes securities, copyrights, patents, insurance, partnerships, and options. Rules on deductions for

most intangible personal property are beyond the scope of this article. For publicly traded stock held > 1 year, you may deduct the fair market value as of the contribution date. For appreciated intangible property, you're better off donating rather than selling, paying capital gains tax, and contributing cash.
